#### Title of Decision:

To undertake a statutory consultation on the proposed "Borough of Dacorum (Water Lane and St Johns Well Lane Berkhamsted) (Off-street Parking Places) Order 2018" Traffic Regulation Order

## **Decision made and reasons:**

To engage Project Centre Ltd to undertake a statutory consultation on the proposed "Borough of Dacorum (Water Lane and St Johns Well Lane Berkhamsted) (Off-street Parking Places) Order 2018" Traffic Regulation Order

To help mitigate the reduction in available parking spaces in Berkhamsted during the closure of Lower Kings Road car park during the construction of the proposed multistorey facility on the site, the proposed Order would introduce a change to a site designation in St Johns Well Lane car park and a change to maximum stay in Water Lane car park. Change to parking arrangements is expected to be required from September 2018 to October 2019.

The following amendments to arrangements in car parks in Berkhamsted are proposed to be made:

- St. John's Well Lane car park designation changed from segregated long (4-10 hours) and short stay (0-4 hours) car park to an any stay car park (maximum stay ten hours)
- Maximum stay in Water Lane, car park revised from four to two hours.

## **Value for Money:**

Based on previous projects, the costs of implementation are estimated to be approximately £17,700, The cost will be met from the Parking Services 'consultancy budget'

The consultancy selected for this function have previously carried out consultations and design works for DBC and are familiar with the area. They are also one of the named contractors in the framework agreement for the provision of consultancy for traffic related operations and parking with Watford Borough Council which is available to Dacorum Borough Council.

# **Options Considered and reasons for rejection:**

Option considered and rejected, not to propose to introduce any support for loss of parking spaces at LKR, but this was rejected as the Council are aware that the closure of Lower Kings Road car park will have an impact on parking within Berkhamsted town centre

If the Council chose not to consult on the proposed changes, then we would not be able to enforce parking against the amendments that we are trying to bring in. The amendments are being introduced to help to mitigate the loss of parking spaces due to the closure of Lower Kings Road car park whilst the multi-storey car park is under construction.
