

## DACORUM BOROUGH COUNCIL

### THE BOROUGH OF DACORUM (STATION ROAD, TRING) (RESTRICTION OF WAITING) ORDER 2018

Dacorum Borough Council, pursuant to arrangements made under section 19 of the Local Government Act 2000<sup>a</sup> and the Local Government (Arrangements for Discharge of Functions) (England) Regulations 2012<sup>b</sup> with the Hertfordshire County Council, and in exercise of the powers conferred on that County Council under sections 1, 2(1), 2(2), 4, 45, 46, 47, 49, 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984<sup>c</sup> ("the Act of 1984") and of all other enabling powers, and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. This Order may be cited as "The Borough of Dacorum (Station Road, Tring) (Restriction of Waiting) Order 2018" and shall come into force on 4 March 2019.
2. (1) In this Order:-
  - "Council" means Dacorum Borough Council;
  - "enactment" means any enactment, whether public general or local, and includes any order, bye-law, rule, regulation, scheme or other instrument having effect by virtue of an enactment; and
  - "the Order of 2015" means The Borough of Dacorum (Various Roads, Tring) (Restriction of Waiting) Order 2015<sup>d</sup>.
- (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
- (3) Unless the context otherwise requires, any expression used in this Order which is also used in the Order of 2015 shall be construed as having the same meaning as given in that Order.
- (4) The Interpretation Act 1978<sup>e</sup> shall apply for the interpretation of this Order as it applies for the Interpretation of an Act of Parliament.
