1.0 INTRODUCTION AND PROCESS SO FAR

1.1 Context

- 1.1.1 To ensure that all recently introduced restrictions at Marlowes are covered by the most up to date and current enforcement legislation, an amendment to the existing order was proposed.

1.2 Proposals

- 1.2.1 It is proposed to make a minor amendment to the existing THE BOROUGH OF DACORUM (MARLOWES, HEMEL HEMPSTEAD) (ON STREET CHARGING AND WAITING & LOADING RESTRICTIONS) ORDER 2022 (“The Order of 2022”) to incorporate recently introduced enforcement legislation.

Article 21 of The Order of 2022 is to be amended by the substitution of the wording “The Civil Enforcement of Parking Contraventions (Guidelines on Levels of Charges) (England) Order 2007” by the wording “The Civil Enforcement of Road Traffic Contraventions (Approved Devices, Charging Guidelines and General Provisions) (England) Regulations 2022”.

1.3 Previous Consultations

- 1.3.1 A previous complete Traffic Regulation Order process has been carried out for the original THE BOROUGH OF DACORUM (MARLOWES, HEMEL HEMPSTEAD) (ON STREET CHARGING AND WAITING & LOADING RESTRICTIONS) ORDER 2022. The order has subsequently been made.

2.0 NOTICE OF PROPOSAL (PUBLIC CONSULTATION)

2.1 Methodology

- 2.1.1 The Notice of Proposal (Public Consultation) process took place from 11th January 2023 to 11th February 2023. During this process, Site Notices and Plans were erected on street furniture on site, the Notice of Proposal documents were made available on the Council website, and they were also published in the Hemel Hempstead Gazette.

- 2.1.2 A copy of the Notice of Proposal document package is included as Appendix A.

2.2 Consultation Responses

- 2.2.1 Following the completion of the Notice of Proposal (Public Consultation) process, no responses were received from the Statutory Consultees nor the general public.

2.3 Conclusion

- 2.3.1 In light of the above, it is clear that the Statutory Consultees and the general public consider the amendment order proposal on Marlowes to be acceptable.

3.0 SUMMARY AND RECOMMENDATION

- 3.1 Dacorum Borough Council have undertaken an extensive Notice of Proposal (Public Consultation) process with regards to proposed changes to enforcement legislation for THE BOROUGH OF DACORUM (MARLOWES, HEMEL HEMPSTEAD) (ON STREET CHARGING AND WAITING & LOADING RESTRICTIONS) ORDER 2022.
- 3.2 Site Notices were erected on street furniture on site, the Notice of Proposal documents were made available on the Council website, they were also published in the Hemel Hempstead Gazette.
- 3.3 No comments have been received from the Statutory Consultees nor the general public. It can therefore be concluded that they deem the amendment to be acceptable.
- 3.4 It is therefore recommended to continue to make and implement the Traffic Regulation Order as proposed.
