Disabled Reduction



When can I apply?

If you have adapted your home to meet the needs of a disabled person who lives there, and he or she is permanently and substantially disabled, you may be entitled to a reduction in the amount of Council Tax you have to pay

The adaptations that qualify are:

- A room (not a kitchen or bathroom), mainly used by the disabled person; (Please note: the room must not be able to be used for its original and intended purpose. The room must be adapted or altered to meet the person(s) disability or needs.)
 - An extra kitchen or bathroom needed to meet the disabled person's needs; or
 - Enough floor space for a wheelchair that is used indoors.

Small modifications alone (e.g. a stair lift or bath hoist) are not reasons for us to grant relief.

The property must be the disabled person's main home.

Until 1 April 2000 you could not apply for a disability reduction if your property was in Band A. If you have been previously turned down for this reason, you can apply again.

How do I apply?

If you think you meet these conditions, fill in the Disabled Band Reduction Form and send it back to us. Our inspector will call to arrange a visit to your property to decide if you are entitled to the reduction.

What happens if I qualify?

We will send you out an adjusted bill, charging you as if your property were in the valuation band below the one the Listing Officer has given it.

If your property is already in the lowest band (A), you will get a reduction of one ninth of the band D charge. If you qualify for disabled relief, you will still be entitled to any other benefit or discount you may already receive on your Council Tax bill.

We will keep any information you provide on the application form on our system, and we may check it with other information we have. We may also give it to other council departments such as Housing Benefit. This is allowed under the Data Protection Act 1998.

If you knowingly give us false information to obtain a reduction, you may incur a penalty and as a result any discount or reduction will be removed.

If we give you a reduction and the circumstances of the household change, you must notify us within 21 days.
