



## Marlowes Pedestrianisation Vehicle Permit Scheme Terms and Conditions

Vehicular access to the Marlowes pedestrian area is at the discretion of the Dacorum Borough Council (DBC) and will only be permitted under exceptional circumstances through the Vehicle Permit Scheme. Permitted vehicles under the 'Pedestrianised Vehicle Permit scheme' are subject to DBC's terms and conditions and may be subject to a fixed penalty notice (FPN) under Traffic Regulation Orders if you are found entering Bridge Street or on the Marlowes pedestrian area without a permit ([www.dacorum.gov.uk/marlowespvp](http://www.dacorum.gov.uk/marlowespvp)).

Permit holders will be given vehicular access via Bridge Street, through the Automatic Number Plate Recognition (ANPR) operated automatic bollards in order to enter the Marlowes pedestrian area, subject to acceptance of these terms and conditions (including the attached plan).

The Marlowes pedestrian area and entrance route through Bridge Street are monitored by 24 hour CCTV.

Please note that no paper permit will be issued, registration details of those vehicles with permitted access will be stored electronically and access permitted as agreed subject to the agreed time periods and dates. ### TERMS AND CONDITIONS

1. Permits are non-transferable and apply only to the vehicles stated in the application form. No paper permit will be issued, vehicle details will be entered into the Automatic Number Plate Recognition (ANPR) system to permit access through the bollards.
2. Please read these Terms and Conditions in conjunction with the Marlowes Pedestrianisation Vehicle Permit Scheme Plan.
3. Vehicular entry to the pedestrian area of Marlowes is only permitted from the junction of Waterhouse Street/Bridge Street.
4. Exit is only permitted from Moor End Road at the southern end (between Primark and Next).
5. Following another vehicle through the barrier is strictly prohibited; the barrier will raise automatically after the permitted vehicle has entered and may result in damage to your vehicle.



6. Any vehicle accessing Bridge Street without a valid permit may be subject to Fixed Penalty Notice (FPN) enforcement.
7. Any vehicle accessing Marlowes Pedestrian zone without valid permit authorisation may be subject to FPN enforcement.
8. Dacorum Borough Council will not be liable for any damage or injury to your vehicle or other vehicles or persons caused by the permitted vehicle being driven without due care and attention.
9. Vehicles are advised not to exceed 5 mph and must have hazard lights on whilst moving in the pedestrianised area. Pedestrians have priority in this zone and vehicles must ensure they give way to them.
10. Vehicles must not exceed 7.5 tonnes in total gross weight unless approved in advance by DBC. Approval will not be provided except under exceptional circumstances.
11. Vehicles are not permitted to reverse in this zone.
12. Vehicles must not unnecessarily block public access or shop premises.
13. Compensation will be due to Dacorum Borough Council in the event of any damage caused by a vehicle.
14. Failure to comply with these conditions will result in your access being permanently revoked and future applications being refused.
15. In the event of a power failure or breakdown of the system, the bollards will automatically lower or the adjacent manual posts will be lowered to enable free access and exit.
16. Your vehicle must be roadworthy and have a valid road tax licence at all times.
17. Where building works or shop fits are taking place a mobile number for a contact on site **MUST** be given.
